Installation

Note: The following instructions show how to install the driver on a Windows 7 computer.

- Without connecting the U209-006-RJ45-X, power on your computer and insert the driver CD that came with the product into your computer's CD ROM drive. If your computer does not have a CD-ROM drive, you can download the drivers from www.tripplite.com/support.
- Click on the CD icon to access its file contents, then click on the corresponding driver file to run the driver installation application.
- 3. When the driver installer program launches, follow the prompts to install the driver.

 Connect the U209-006-RJ45-X to an available USB port on your computer. Windows will detect the adapter and assign it a COM port upon completing the installation.

6. To verify that your adapter has been successfully installed, navigate to your computer's Control Panel and open the Device Manager screen. The adapter will appear in the Ports section, with its assigned COM port next to it.
